Hello everyone.

Two newsletters in 2 weeks, better back off on those energy drinks.

As promised this edition details decisions from the June committee meeting.

The big-ticket item: The kiosk as per the Victorian Titles will return permanently. Indy's grandma has volunteered to run the kiosk which will offer fresh coffee and hot food (as well as the traditional drinks and sweets). We are now hunting down a pie warmer and a Dim Sim steamer. As soon as we have these, the kiosk (old control room) will run from around 6 or 6:30pm to around 8:30pm. Demand will fine tune the operating period.

There are some minor changes to our web site.

Alycat support ceases at the end of this year as its author is retiring. Ken has developed and supported Alycat over the past 30 odd years. At present we don't know of any equivalent products that manage 'rounds' style racing. For the time being Alycat is stable and no reasons why it can't continue to serve our club for the next few years. Over this period, we will investigate the suitability of alternative products.

### **Boronia Code of Conduct (CoC)**

A new document "BRCCC Class Rules" has been created and now available on our web site (got to the "Classes" tab). This document is a copy of the rules in our CoC with just one update regarding battery charging. The class rules in our Code of Conduct will be deleted with the next edition of the CoC at the end of the year.

The above change is part of our strategy to simplify and improve documentation on rules, policies and Constitution/ Governance.

The next BRCCC AGM is scheduled for Wednesday August 1<sup>st</sup> after round 1.

All financial club members are welcome to nominate for committee positions and we would love to see some new blood join the 2018/2019 committee.
